- PAYMENTS WILL BE RETURNED IF CHECK IS NOT WRITTEN FOR THE EXACT AMOUNT DUE OR NOT WRITTEN PAYABLE TO WESTFIELD ACADEMY AND CENTRAL SCHOOL
- IF TAXES ARE RECEIVED AFTER THE DUE DATE, AND DO NOT BEAR AN OFFICIAL POSTMARK DATE, A PENALTY MUST BE ADDED AND COLLECTED AND NO TAX RECEIVER/ COLLECTOR OR OFFICIAL CAN WAIVE THE PENALTY, (OP, STATE COMPT.68-626)
- UNDER NEW YORK STATE REAL PROPERTY LAW 922- YOU ARE STILL RESPONSIBLE FOR PAYMENT OF YOUR TAXES EVEN IF YOU DID NOT RECEIVE A BILL.

IMPORTANT: If this property has been sold or otherwise disposed of you are required to forward this Tax Bill to the new owner or return it to the Tax Receiver/ Collector.

IMPORTANT NOTICE: The penalties are as follows:

- September 1, 2026 thru October 2, 2026 – penalty free
- October 3, 2026 thru November 3, 2026 – 2% penalty
- Taxes paid November 4, 2026 thru November 20, 2026 – pay to Chautauqua County
After November 3, 2026, the unpaid taxes will be returned to the Chautauqua County Taxation Department for collection or relevy and cannot be received by the School Tax Receiver/ Collector. See below for details

November 20 IS THE LAST DAE TO MAKE PAYMENT OF THE 2026-2027 SCHOOL TAX TO THE COUNTY

At the conclusion of the collection period all taxes unpaid will be returned to the Chautauqua County Real Property Tax Office, 3 N Erie Street, Gerace Office Building, Mayville, NY 14757-1007, Payments including fees will be accepted until November 20, 2026 at which time no further collections will be accepted. Any school taxes remaining unpaid at the conclusion of business on November 20, 2026 will be releived onto the 2027 County-Town Tax bill with an additional 7% relevy fee added.

IF YOU ARE A SENIOR CITIZEN, A PERSON WITH A PHYSICAL DISABILTY AND/OR A VETERAN, YOU MAY BE ENTITLED TO A PARTIAL EXEMPTION FROM PROPERTY TAXES. Eligible homeowners have until March 1, to apply for such exemptions. For further information please contact the assessor's office in the town you live in.

THIRD PARTY NOTIFICATION -SENIOR CITIZENS AND DISABLED PERSONS

New York State law now provides that if you are age 65 or over, of disabled, and you own 1,2 or 3 family residential property, you can designate an adult third party to receive duplicates of your tax bill and all required notices deriving therefrom. You and the person you designate must both sign the application. You may obtain an application (R-923) at the office of the Tax Receiver/Collector or at the office of the County Director of Real Property Tax Services. If you wish to receive an application by mail, please send a self-addressed, stamped envelope with your request to either the Tax Receiver/Collector or the Director of Real Property Tax Services , 3 N Erie Street, Mayville, NY 14757-1007. Phone number (716) 753-4221. You must file your application prior to July 16th to be effective for the ensuring year. Once the application is approved and filed a duplicate of your subsequent Tax Bill and all required notices of unpaid taxes will be mailed to the adult or third party until you notify the Tax Receiver/Collector or the County Director of Real Property Tax Services to cancel your authorization.
